Course description

The aim of this course is to increase your awareness and ability to think soundly and critically about the concepts, principles, theoretical frameworks and practical considerations that prove useful in understanding how society shapes the law and how law shapes society. We will address such issues as the role of law in society, whose interests the law serves, the law's role in societal transformation and the role that law plays in determining how we think about issues and the role that society's culture plays in defining law, its key concepts and principles. Accordingly, we will emphasize the social, political, cultural and epistemological aspects of the law, rather than legal doctrines, statutes or judicial opinions (though at times these aspects of the law will be raised). This enables us to understand how the law influences and is influenced by social change, social reproduction and inequality (including race, class, gender, and sexuality). We will also analyze the role of law in contemporary legal issues related to these topics in order to understand and evaluate how the law seeks to achieve certain objectives such as compliance, deterrence and social control.

As a result of taking this course, students will be able to do the following:

- Evaluate how and why different individuals and groups view the law in certain ways and how the law impacts individuals' lives differentially;
- Explain the relationship between the law and morality in connection with society;

• Demonstrate the skills necessary to discuss critically and analyze soundly the circumstances under which and the role that law is capable of playing in, social change and reproduction, social control, compliance and deterrence, and equality or inequality; and

• Critically discuss and analyze the law's relationship to categories of identity such as race, gender, class.
